Description: I am the owner of a thriving group practice where I provide psychotherapy, as well as forensic, neuropsychological, parenting, and comprehensive psychological and diagnostic evaluations. I see individual, couples, and families in therapy for difficulties ranging from complex trauma and PTSD to bereavement, anger management, depression, anxiety and general life adjustment. I offer an integrated and collaborative therapeutic approach pulling from multiple therapeutic modalities and empirically supported treatments. I utilize trauma specific treatments such as Eye Movement Desensitization and Reprocessing (EMDR) and Cognitive Processing Therapy (CPT), as well as evidenced based treatments such as Cognitive Behavioral Therapy (CBT), Dialectical Behavior Therapy (DBT) and Acceptance and Commitment Therapy (ACT). I also utilize my Therapy Dog, Boomer, as a co-therapist and he has been a great asset to my practice.

In addition to therapy, I provide psychological evaluations for a wide variety of referrals, such as diagnostic clarification referrals from psychiatrists, ADHD evaluations, court ordered mental health evaluations, learning disorder evaluations, psychological evaluations with a parenting component, parenting evaluations, neuropsychological evaluations, general forensic assessments, risk assessments for violence and abuse potential and revictimization, and disability assessments. I am currently contracted to complete psychological, neuropsychological, and disability evaluations for the Division of Disability Determination Services (DDS) and Social Security. I am also contracted to completed psychological and neuropsychological evaluations with a parenting component for the Department of Children Youth, and Families (DCYF). I have completed hundreds of evaluations in my career thus far, not only for the organizations and agencies listed above, but also private forensic evaluations for parenting and custody related issues, as well as psychological, risk and neuropsychological evaluations for civil, criminal, and personal injury cases.

**Behavioral Health Consultant, HealthPoint – Midway (Des Moines, WA)**

Description: I worked as Behavioral Health Consultant at HealthPoint, a community health clinic in South King County, for 11 years. Working in collaboration with primary care physicians and other providers to identify, triage, and co-manage patients with medical, neurological, and behavioral health problems within a primary care setting, I worked with patients to provide support, skills training, and behavior management through psychoeducation and brief interventions. I also ran multiple groups that are aimed at providing additional treatment to the more complex patient populations, including a chronic pain support group, diabetes support groups, a successful depression and trauma related support group, and in 2016 developed a perinatal support group that that provided a safe place for women to discuss the challenges that come along with motherhood, as well as perinatal emotional complications that can impact health and wellness.

In addition to helping to treat mental health conditions in primary care, I also served as a clinical supervisor to doctoral students in psychology, taught didactic seminars on treating trauma in primary care, providing neuropsychological and psychological assessments in

primary care, and I ran both group and individual supervision. In my years at HealthPoint, I helped to collaborate with providers on chronic pain treatment and controlled substance management, as well as help develop patient education materials and screening protocols for diabetes, hypertension, depression management, and other chronic diseases. I worked diligently to implement trauma informed care and the screening of adverse childhood experiences (ACE's) into my practice and hope to work in collaboration with the Northwest Primary Care Association to implement screening and treatment protocols for complex trauma in primary care and school settings.

In collaboration with a previous professor and mentor Laura Brown, Ph.D., ABPP, I worked to create a local training program for doctoral interns that could focus on providing quality therapy to low-income populations. As the first ever intern at FCTP, I was responsible for helping to create this training program and not only develop programs for therapy and treatment that were cost-effective, sustainable, and accessible to all, but also ensure that people within the community could continue care with other high quality and well-trained practitioners. As the senior intern, I worked full time providing trauma and feminist informed therapy and psychological evaluations to children, adolescents, adults, couples, and families without means. I supervised students in their learning and development, and also learned to build a private practice from the ground up.

Duties: Working with male offenders in the minimum and maximum security units at MCC where I was responsible for providing individual therapy and group therapy to offenders, as well as performing forensic evaluations and risk assessments for parole and changes in custody.

While working for the Department of Corrections, I completed over 300 risk evaluations assessing likelihood that an individual would commit future acts of violence or other crimes. I also complete my doctoral dissertation on risk assessments with the offenders at the Monroe Correctional Complex, evaluating over 200 offenders using two new self-report measures, the Psychopathic Personality Inventory – Revised (PPI-R) and the Inventory of Offender Risk, Needs, and Strengths (IORNS). I compared these measures to the current measure used (Level of Service Inventory – Revised, LSI-R) and was able to provide empirical evidence that the two newer measures are better predictors of future risk for violence and re-offense.
